## 2. Housing & Aging in Place

Barb McBeth, City Planner, spoke to the committee regarding Community Development's role in Senior Housing. She outlined ordinances that have been established to set standards that depend on different zoning districts. The Master Plan has been undergoing an update since 2022 and includes an evaluation of the current housing conditions in the City and provides recommendations moving forward. The final draft will soon be presented before the Steering Committee. Planner McBeth spoke about the current housing market in Novi and the "missing middle" which includes medium density, smaller units, smaller lots, walkable spaces. Moving forward, what can be done to fill the gaps? Modifications could be

considered to the ordinance to allow opportunities for aging in place Accessory Dwelling Units or allowing additions to existing homes for "granny flats". Incentives could be provided to developers to include a certain percentage of workforce housing. Her final slide stated "What could be done? Identify specific areas in the City that will be in proximity to healthcare and other services, shopping, and recreational facilities for developing senior living facilities to enable the population of Novi to age in place."
