SUBJECT: Approval to enter into an agreement to purchase Taser equipment for the Uniform Division at the Novi Police Department from Axon Enterprise, Inc., sole source provider, for a total of \$89,067 over a five year period.

BACKGROUND INFORMATION:

Approved in the 2018-19 Budget, was the purchase of Tasers and associated equipment for the Novi Police Department Uniform Division in the amount of \$90,940 over a five year period from Axon Enterprise, Inc., sole source provider in Michigan. Evidence suggests that Tasers reduce injuries to officers and suspects resulting from use of force situations. Tasers were introduced to the Police Department in 2004 and have been a part of the officers standard uniform compliment since the 2008-09 budget.

The Novi Police Department purchased its current Taser X2 Conducted Electrical Weapons (CEW) in July of 2013. Since 2013 the department has acquired fifty-eight CEWs to issue to its members. There are five CEWs in inventory as spares to be switched out for CEWs that are removed from service for maintenance issues. Axon, formally Taser International, advises that the estimated operational life of their CEWs is five-years. Axon advises that the five-year timespan limit was calculated due to electrical components which ultimately fail from use with CEWs over five-years. Axon further advised that they are not liable for failures of the CEW after the five year period and their ten million dollar liability insurance policy will not cover these expired CEWs. There is a possibility that a CEW could fail which may put officers lives and safety in jeopardy as a result of the failure of the CEW.

Axon has a program that they run for law enforcement agencies which is called the Taser 60 Basic. This program runs for a consecutive five years. With the Taser 60 Basic program Axon will discount the first year cost of the purchase of the new X2 CEWs as well as include 120 25 foot smart cartridges, 60 battery packs, extended warranty, an additional download dataport kit, and a spare Taser X2 CEW with battery. Utilizing the Taser 60 Basic program will save the department \$11,391 over a five year period. Legal counsel has reviewed this opines there is no legal impediment which precludes the City of Novi from executing this agreement.

RECOMMENDED ACTION: Approval to enter into an agreement to purchase Taser equipment for the Uniform Division at the Novi Police Department from Axon Enterprise, Inc., sole source provider, for a total of \$89,067 over a five year period.

The Novi Police Department purchased its current Taser X2 Conducted Electrical Weapons (CEW) in July of 2013. Since 2013 the department has acquired fifty-eight CEWs to issue to its members. We currently have five CEWs as spares to be switched out for CEWs that are removed from service for maintenance issues. Axon, formally Taser International, advises that the estimated operational life of their CEWs is five-years. Axon advises that the five-year timespan limit was calculated due to electrical components which ultimately fail from use with CEWs over five-years. Axon further advised that they are not liable for failures of the CEW after the five year period and their ten million dollar liability insurance policy will not cover these expired CEWs. There is a possibility that a CEW could fail which may put Officers lives and safety in jeopardy as a result of the failure of the CEW.

The Novi Police Department plans to purchase sixty (60) Taser X2 CEWs this next fiscal year due to the estimated end of operational life of its current X2 CEWs. Current Axon law enforcement pricing for the X2 CEW is \$1,170 per unit. In addition to the new X2 CEW's the Police Department will also have to purchase PPM battery packs for each unit at \$62 each and one hundred and twenty (120) 25 foot smart cartridges at \$36.00ea. A five year extended warranty on one X2 CEW is \$363.

Axon has a program that they run for law enforcement agencies which is called the Taser 60 Basic. This program runs for a consecutive five years. With the Taser 60 Basic program Axon will discount the first year cost of the purchase of the new X2 CEWs at \$13,013.40 as well as include 120 25 foot smart cartridges, 60 battery packs, extended warranty, an additional download dataport kit, and a spare Taser X2 CEW with battery. Years two through five would be billed at \$19,013.40 which will total after five-years at \$89,067. Utilizing the Taser 60 Basic program will save the department \$11,391.
