### PRESENTATIONS:

1. Hindu Heritage Month Proclamation

Mayor Gatt said we were honored to have in the audience two of the finest Novi residents in the whole world, and we probably have more than two, but he was going to recognize Dr. Mav Sanghvi and Mr. Ramesh Verma. He said Dr. Sanghvi was a former City Council member and present-day Zoning Board of Appeals member and Mr. Verma is a present-day Planning Commission member and former City Council member. He stated that these two men are so active in our community, and he thought it was appropriate that they are here and that he presented this Proclamation to them that evening. He read the Proclamation honoring the Hindu Heritage Month, October 2021. He gave the podium over to Dr. Sanghvi and Mr. Verma.

He said if you name it, every country has a Hindu diaspora. He appreciated Novi recognizing their presence in this great City. He thanked the Mayor very much.

Mayor Gatt thanked Dr. Sanghvi very much and thank you to our entire Indian community. He said he has done so much for our city, and we are all very grateful.

Venkata Reddy Thalla, 450006 Yorkshire Dr., Novi said he has been a resident of Novi for 23 years and he lives across the street in the Jamestown Subdivision. He said he contemplated whether he should speak that evening. He said he has been thinking about it for a month or so. He stated it is just a coincidence that our beloved Mayor had declared October as the Hindu Heritage Month. He came to the USA in 1986, and was the only child to his parents, and maybe his mother was depressed because he was far away and then somehow, she became Christian. He said he was born Hindu and his mother somehow became a Christian, she died Christian. He thought it was interesting that three people came here that evening and declared it the Hindu Heritage Month. He said he came to speak about another topic but changed it on the fly. He said he was the fourth one there representing, and he was representing "I" which is our library logo, Include, Inform, Inspire, and obviously, we are all invited. He said in the Hindu code, a very fundamental thing that is said especially during the marriage for words that is

Dharma, which you already mentioned in the Proclamation or the Karma Moksha. He explained in all his years of learning and experience, he translated that into effectiveness, efficiency, effortlessness, ecstasy, which is happiness. He said that is the state that they are supposed to be in while pursuing those four pursuits. These spouses are not supposed to leave their hand, so that is the pledge that they do. Thank you.
