**SUBJECT:** Approval of Release in Full provided by Travelers Insurance in connection with the claim against it's insured, Asphalt Specialists, Inc., in the amount of \$14,585.87.

## **BACKGROUND INFORMATION:**

On December 3, 2020, Asphalt Specialists, Inc. (subcontracted paver to Merlo Construction, Inc., prime contractor on the 2020 Pathways and ADA Improvements project) were repaying the Hilton Sanitary Lift Station driveway, near 8 Mile and Haggerty Roads, when a sanitary sewer cover and casting was shifted off the manhole which allowed the newly applied asphaltic mixture to fall, settle and compact in the bottom of the structure.

The next day, December 4, 2020, our Water and Sewer Division received a call regarding a sanitary sewerage back-up from the Sheraton Hotel, located immediately upstream from the lift station. Our crews along with Metro Sewer Cleaners, Inc., worked tirelessly through the night jack-hammering and removing the hard, compacted asphalt from the structure until flow was restored.

The City immediately informed both the prime contractor and the paving subcontractor of the damage and was also witnessed by their representatives. Asphalt Specialists, Inc. agreed to reminburse the City completely for the emergency removal of asphalt from the sanitary structure. Travelers Insurance Company, on behalf of Asphalt Specialists, Inc. will issue the City a check in the full amount upon receiving a signed copy of the attached *Release in Full* form.

The City Attorney has reviewed the form and background information and recommends the City execute said form (per attached letter from Elizabeth Saarela dated July 28, 2021).

**RECOMMENDED ACTION:** Approval of Release in Full provided by Travelers Insurance in connection with the claim against it's insured, Asphalt Specialists, Inc., in the amount of \$14,585.87.

## Re: 2020 Pathway Gap Release – Asphalt Specialists, Inc.

Dear Mr. Staup:

We have received and reviewed a proposed Release in Full provided by Travelers Insurance Company in connection with the City's claim against its insured, Asphalt Specialists, Inc. (ASI) in the amount of \$14,585.87. ASI paved the Hilton Lift Station on December 3, 2020 resulting in asphalt entering a sanitary manhole. The City incurred the entire \$14,585.87 in removing the asphalt from the sanitary sewer. It appears that one sewer backup resulted from the asphalt in the sewer on December 4, 2020. However, no claims for sewer backup have been filed with the City as a result. Since claimants only have 45 days to file a sewer backup claim with the City under MCL 691.1419, there is little to no risk in the City agreeing to release the insured and insurer for any additional claims relating to this incident. We see no legal impediment to entering into this Release in Full in order to finalized payment of the claim to the City.
