#### BACKGROUND INFORMATION:

AECOM, engineering consultants to the City, helped develop a list of streets for the 2018 and 2019 Concrete Panel Replacement (CPR) Program. The program was advertised for a two-year contract to capture unit prices and lower the logistical costs of bidding, designing, and construction. This process allows the City flexibility with regards to the scheduling of different project areas. The Concrete Panel Replacement Program work includes concrete pavement repairs to the local road network in an effort to preserve the longevity of the existing roadways.

The roads selected for 2018 Concrete Panel Replacement Program are Bristol Circle, Mclean Court, Winnsborough Lane, Castlewood Drive, Havergale Street, Moorgate Street, Byrne Drive, portions of Cranbrooke Drive, Londonderry Drive, Franklin Mill Street, Sunrise Boulevard, Ladene Lane, Arbor Lane, Greentree Lane and Clover at Greentree Lane Roscommon Drive, Pellston Drive, Glen Haven Circle East, Broquet Road, and Onaway Drive.

The roads selected for the 2019 Concrete Panel Replacement Program are Waycroft Drive, Courtview Trail, Roxbury Drive, Carlisle Court, Cherry Hill Road, Park Ridge Court, portions of Cranbrooke Drive and Nilan Drive.

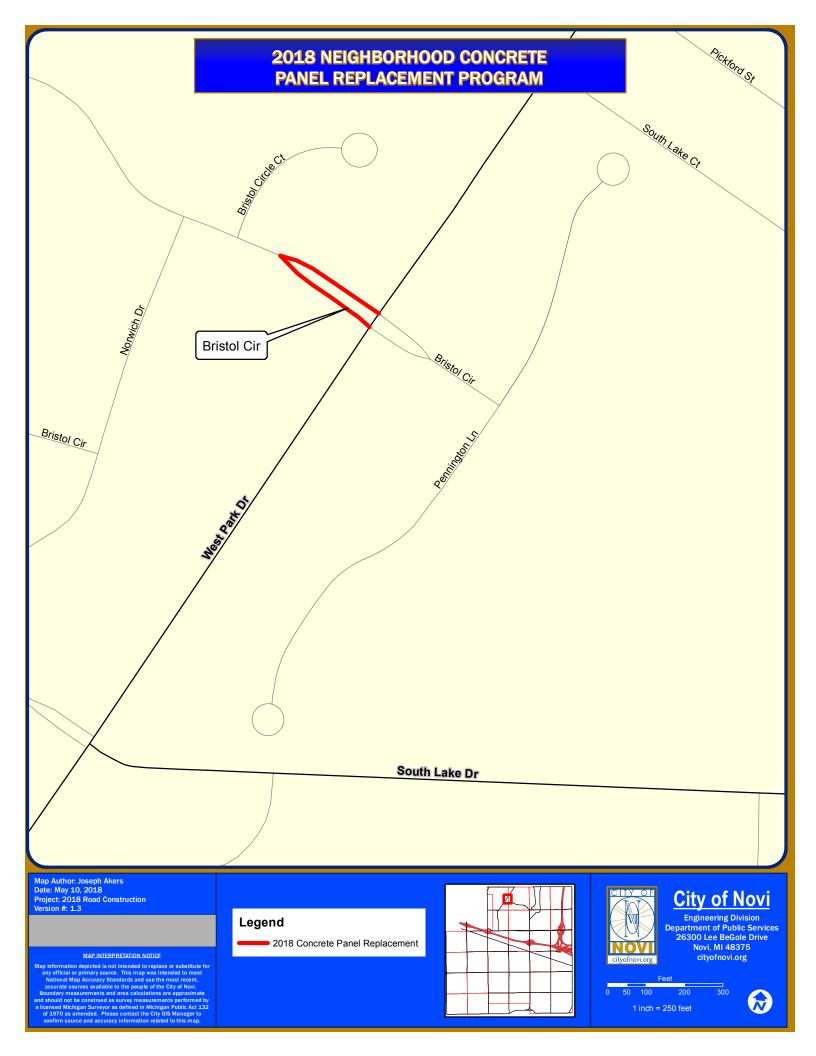
AECOM assisted the Engineering Division with developing the plans for this project. The plans were advertised for public bids on April 30, 2018. Seven (7) bids were received and opened on May 14, 2018 following the solicitation period. Great Lakes Contracting Solutions' bid is being recommended as being in the best interest of the City as it is responsive and complies with all of the requirements of the bidding instructions. The award recommendation letter including the bid tabulation is attached. A summary of the bid tabulation is as follows:

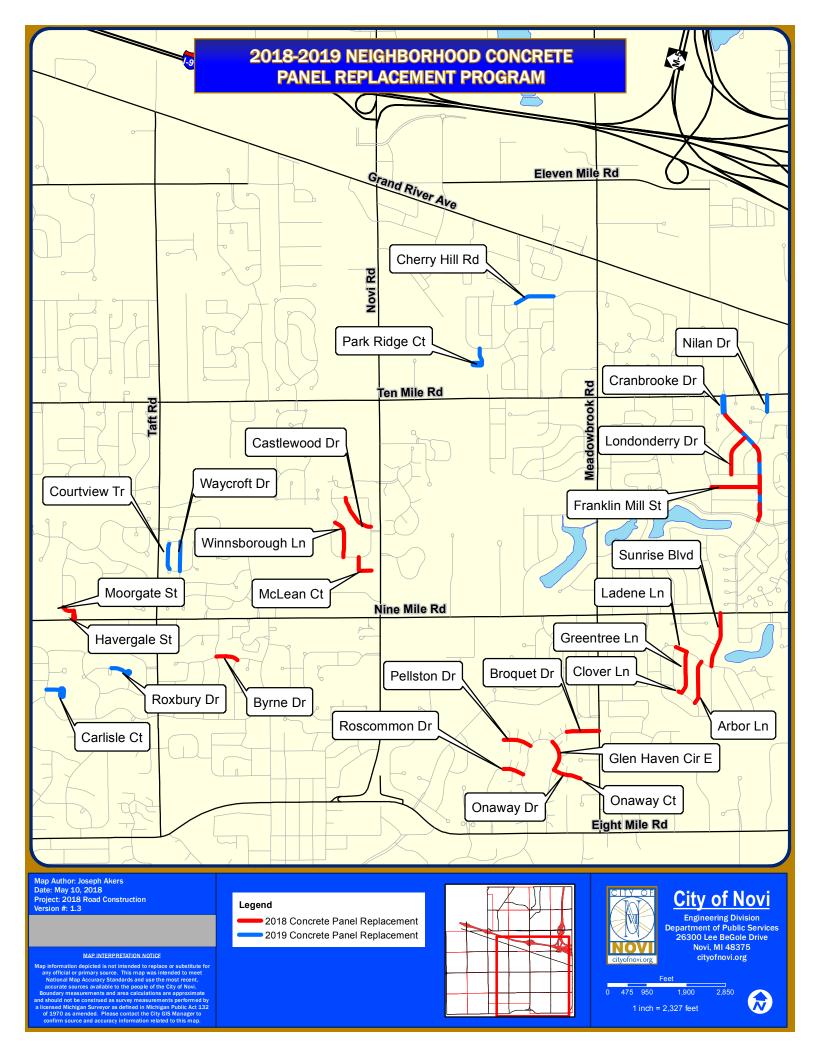

Attached is the Bid Tabulation for the above referenced project. Seven bids were received and opened. This bid is under the latest Engineer's Estimate. The following irregularities were noted in the bids:

There were minor errors in the low bid estimate. Different unit prices were used in the 2018 Bids and 2019 Bids. The award is based on the 2018 Bid prices for both 2018 and 2019 Bids.

The other bids also had minor arithmetic errors and different unit prices in the 2018 Bids and 2019 Bids. These errors did not affect the outcome of the bidding.

Great Lakes Contracting Solutions, the low bidder, has successfully completed similar projects in the City of Novi, City of Southgate, and City of Westland. The bonding company listed in the Statement of Qualifications has an AM Best rating that exceeds the minimum requirements.

We recommend award of the 2018 Concrete Panel Replacement Program and 2019 Concrete Panel Replacement Program contract, to Great Lakes Contracting Solutions for the Bid Amount, excluding crew day costs, of \$1,622,869.75.

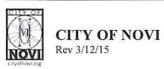
