BACKGROUND INFORMATION:

In connection with the Warranty Deed accepted by City Council on January 9, 2017, ten additional feet of right-of-way of the subject parcel needs to be dedicated to the Road Commission for Oakland County since it has jurisdiction over Grand River Avenue. The Road Commission is willing to accept the right-of-way, and if approved by City Council, the Quit Claim Deed would be presented to the Board of Road Commissioners for formal acceptance.

The enclosed letter by the City Attorney (Beth Saarela, October 3, 2018) provides the Quit Claim Deed that was prepared for this dedication and is recommended for acceptance.


